From the Desk of the Administrator



Dear Colleagues,

Students and mass people uprising in Bangladesh during July and August, 2024 have paved the way for heralding changes in many sectors including trade and businesses. The youth-led movement also demanded for corporate accountability and reforms in the business sector.

The pressure was so powerful that many institutions unwilling to bring coveted changes were compelled to undertake changes hitherto unthinkable. I am really indebted to the government and FBCCI for providing me this wonderful opportunity. Taking the opportunity, I would like to put it on record that I shall leave no stones unturned to conduct a reliable, acceptable and participatory election for FBCCI. I

am also committed to bring necessary reforms in this business body after threadbare consultation and meeting with chambers and associations and its leaders. The month of October is very important due to this consultation processes. During this month we have initiated discussion formally and informally with business leaders and member of trade bodies.

Though there were some set back in trade & business during July-August uprising, but with the passage of time, things have settled down and now business is getting momentum, inflation is gradually contained. FBCCI though is run by administrator, it has not deviated from it's goals. FBCCI still remains committed to its mission of promoting and protecting the interests of the private sector through providing valuable insights and creating opportunities.

I extend my heartfelt gratitude to all our members, partners, and stakeholders for congratulating me and giving their support to FBCCI's endeavors. Together we aspire to bring change and reforms in the economic & trade sector of Bangladesh. We also look forward to a democratic and business friendly milieu in our country.

Consultation with Chamber & Association leaders on Reforms & Election of FBCCI



A series of meetings with the leaders of Chambers and Associations on FBCCI's reform and election were held virtually on 20, 23, 27 and 28 October, 2024.

A number of recommendations were raised by the representatives of Chambers and Associations. They mainly called for election of office bearers and directors by direct voting by general body members, rationalization of numbers of FBCCI Board, interval of candidature after consecutive 2 (two) term election, formulation of criteria for selecting GB members etc. They were also opined for abolition of nominated director system.

FBCCI Secretary General Mr. Md. Alamgir, Head of International Wing Mr. Zafar Iqbal ndc, Additional Secretary General Shah Md. Abdul Khaleque and other officials also joined the meeting.

Discussion Meeting on Stabilizing the Market of Essential Commodities

FBCCI hosts a discussion meeting with retail and wholesale traders, aiming to stabilize the market of essential commodities including egg, chicken, onion and potato. The meeting was held at FBCCI Board Room on October 17, 2024.


FBCCI Administrator Mr. Md. Hafizur Rahman chaired the meeting.

But prices have abnormally been increasing nowadays, which has caused discomfort to consumers. The business community needs to ing. work together to reduce unnecessary handling and deliver goods to consumers at reasonable prices.



Retailers and wholesalers called upon producers and corporate entities to ensure the normal supply of essential commodities like eggs, chicken, onions, and potatoes to stabilize market prices.



Bangladesh- Argentina Trade Opportunities and Challenges

The relation between Bangladesh and Argentina reached a new height when at the end of Qatar world cup in 2021, Argentinian Foreign Minister came to Bangladesh in 2022 to inaugurate the Embassy building of Argentina in Bangladesh. In the Qatar World Cup, Bangladeshi fans wholeheartedly supported the Argentinian team which created a great sensation among the Argentinian People and government. It is this football mania that was a great factor to expedite the strong relationship between the two countries. The friendship between the two countries which was based on football ultimately transformed into business and other relations.

Bangladesh imported products such as soybean oil, sugar and edible oil worth \$791 million from Argentina in the 2022-23 fiscal year. On the other hand, Bangladesh exported products worth \$9.52 million during the same FY. There are opportunities for better trade with Argentina. There is a huge trade deficit with Argentina and Bangladesh can minimize that trade gap by increasing exports, especially of RMG items. If barriers are removed, Bangladeshi exports can reach to \$1-1.5 billion in the short time.

Bangladeshi goods, such as garments, jute and leather products, generic drugs, pharmaceutical products, ceramic and plastic, home textiles, agricultural and processed agricultural products, shrimp, frozen food, bicycles, refrigerators, air conditioners, light engineering products have a good chance to be exported to Argentina, Brazil, Uruguay and Paraguay.

But as ill luck would have it, Bangladeshi products face tariffs ranging from 8% to 35% when entering the Argentine market. In addition, there are also barriers such as anti-dumping policies. Argentina has imposed an anti- dumping duty of \$16 per kg on Bangladeshi jute bags and sacks.

It is against this reality that Free Trade Agreements (FTA) or Preferential Trade Agreements (PTA) with other countries, including Argentina and other members of the Southern Common Market, commonly known as Mercosur should be signed at the earliest. For this initiative G2G and B2B initiatives should be started soon. The present delegation is visiting Brazil to explore such opportunities and to establish people to people, B2B connectivity.

Last year, Bangladesh and Argentina, signed three agreements and a MOU with the visiting Argentine Minister of Foreign Affairs, International Trade and Worship Mr. Santiago Andrés CAFIERO with his counterpart in Bangladesh.

Under the MoU Bangladeshi footballers will have the opportunity to get training in Argentina. Another two agreements include cooperation between the sports academies of the two countries, and allowing Bangladeshi government officials to travel to Argentina without Visa.

During the visit Argentine Foreign Minister Santiago Cafiero opened the new Argentine Embassy in Dhaka. With the reopening of the embassy and its consular section, the country seeks to exploit the potential of the bilateral relationship, mainly in the commercial aspect.

Executives from companies - Marolio, Ecofactory, Vetanco, Lipotech, Luna de los Andes, Letis, Santo Pipó, Instituto Nacional de la Yerba Mate (INYM), The Halal Catering Argentina HCB, Havanna, Arcor, Baltazar -Alfa Pampa, Suplefeed, Ronaldb, Club Atlético River Plate and Cargill - travelled with Cafiero.

In 2022, bilateral trade with Bangladesh was US\$765 million. Argentine exports reached US\$742.9 million and imports from Bangladesh totaled US\$22.1 million. A trade surplus for Argentina of US\$720.8 million was registered in 2022.

Bangladesh and Argentina also signed a memorandum of understanding for the first time for bilateral cooperation in the field of agriculture. Under the MoU, Bangladesh will receive priority in smart agriculture technical support, greater agricultural trade and collaboration including the import of wheat and soybeans.
