#### Vietnam-Bangladesh Business Forum 2025 hosted by FBCCI



The 'Vietnam-Bangladesh Business Forum 2025' was held on 14 May 2025 at Hotel InterContinental Dhaka.

A 16-member Vietnamese business delegation, led by H.E. Phan Thi Thang, Deputy Minister of Industry and Trade of Vietnam, joined the forum. The event was hosted by FBCCI.

Emphasizing the need for boosting bilateral trade and investment between Bangladesh and Vietnam, both countries stressed on the need of trade agreements and economic partnerships.

Addressing the forum, Vietnamese Deputy Minister of Industry and Trade H.E. Phan Thi Thang called for easing of tariff and non-tariff barriers to strengthen bilateral trade and investment between Bangladesh and Vietnam.

She highlighted the trade potential in sectors such as agriculture, tourism, pharmaceuticals, fisheries, and ICT.

Additionally, she stressed the importance of further developing connectivity, transportation, and logistics to unlock opportunities in untapped sectors. She also recommended mutual cooperation, technology transfer and information sharing between businesses of the two countries.

Echoing similar views, Additional Secretary of the Ministry of Commerce of Bangladesh Mr. Abdur Rahim Khan underlined the importance of minimizing tariff and non-tariff barriers to facilitate trade and investment between Bangladesh and Vietnam. He also suggested further simplification of transaction mechanisms between the two countries.

In his welcome address, FBCCI Administrator Mr. Md. Hafizur Rahman noted that the opportunities for enhancing trade and investment are vast and remain largely untapped. Key sectors such as infrastructure development, renewable energy,

agro-processing, and the growing tech industry in Bangladesh hold immense potential for collaboration. Similarly, Vietnamese expertise in manufacturing, particularly in electronics and high-value agriculture, can find a receptive and expanding market in Bangladesh, he added.

Vietnamese Ambassador to Bangladesh H.E. Nguyen Manh Cuong emphasised the importance of joint ventures and mutual cooperation to expand trade between the two nations. Bangladesh's Ambassador to Vietnam H.E. Mohammad Lutfor Rahman called for ease of business visa to strengthen trade ties.

Mr. Do Van Trung, head of the Vietnam Business Association, highlighted the need for deeper communication and partnerships among entrepreneurs and businesses from both countries.

Secretary General of the FBCCI Mr. Md. Alamgir, Former Director of FBCCI and member of the Shohayok Committee Mr. Abdul Haque and Ms. Nasreen Fatema Awal, Former Director of FBCCI Dr. Ferdousi Begum, Business Leaders, General Body Members of the FBCCI Mr. Zakir Hossain (Noyon), Mr. Zakir Hossain and others were present in the forum, among others.



#### FBCCI hosts a Seminar on Women in Technology



FBCCI, the country's apex trade body, organized a seminar titled 'Women in Technology' in honor of the visiting business delegation from Saudi Arabia on 08 May 2025 at the FBCCI office in Motijheel, Dhaka.

FBCCI Administrator Mr. Md. Hafizur Rahman chaired the seminar.

Mr. Shish Haider Chowdhury, ndc, Secretary of the Information and Communication Technology (ICT) Division, graced the seminar as the Chief Guest.

In his address, the ICT Secretary emphasized the government's commitment to promoting women's engagement in technology. He highlighted ongoing initiatives aimed at fostering a women-led economy through employment and entrepreneurship, thereby ensuring

women's empowerment and development. Commending FBCCI for hosting the seminar, he stressed the importance of women's participation in technology in the context of the Fourth Industrial Revolution (4IR).

Speaking as the special guest, Nurun Nahar Chowdhury, additional secretary (development) at the Energy and Mineral Resources Division, addressed the social challenges women face. 

The meeting also discussed on mutual trade & commerce related interests

between FBCCI and ACCI for strengthening bilateral ties. The MoU between the two chambers is expected to facilitate exchange of information and research on different areas of cooperation with a view to promote bilateral commercial relations. It will also facilitate in exploring possibilities of Joint Ventures in the areas of ship building, ICT & agriculture etc.

Joining the meeting, Mr. Md. Hafizur Rahman, Administrator of FBCCI emphasized on deepening bilateral trade in the sectors like leather, fisheries, textile, pharmaceuticals, plastic, processed food, flower etc. and called upon the Algerian businessmen to invest in Bangladesh.

The meeting highlighted monthly updates, key decisions, disaster management strategies, and solid progress under BPP2 with impactful presentations.

Three district-level meetings titled "Strengthening Local Business Community on Disaster Resilience" were organized by FBCCI Safety Council and the safety cell of the Cox's Bazar Chamber of Commerce and Industry (CBCCI), Kurigram Chamber of Commerce and Industry (KCCI), and the Bagerhat Chamber of Commerce and Industry (BCCI).





The first meeting was chaired by Mr. Abu Morshed Chowdhury, President of the Cox's Bazar Chamber of Commerce and Industry, held on 14 May 2025 at Cox's Bazar. Thirteen local business associations were participated the meeting.

The second meeting was chaired by Alhaz Abdul Aziz Mia, President of the Kurigram Chamber of Commerce and Industry, held on 21 May 2025 at Kurigram. It engaged about fifteen local business associations.

The rest of the meeting was chaired by Mr. Sk Mainul Islam Mostafa, Convener of the Sommilito Business Owners Association of Bagerhat, on 28 May 2025 at Bagerhat. It also engaged about 14 local business associations. Beside this, team FBCCI Safety Council met with additional executive director of the Mongla EPZ and discussed on formation of a private sector emergency response team at the export processing zone of Mongla, Bagerhat. They principally aggreed to extend cooperation in the initiatives of FBCCI regarding disaster resilience.

Additionally, 33 business associations in Kurigram, Cox's Bazar and Bagerhat have been assessed regarding their disaster preparedness capacity using the new tool.

#### **AI-Powered Trade Transformation in Bangladesh**

In an era marked by rapid technological advancement, Artificial Intelligence (AI) is emerging as a powerful tool that can revolutionize industries worldwide.

Bangladesh, a nation with a thriving economy with strategic geographic location, stands poised to harness the potential of AI to transform its international trade landscape. By integrating AI into its trade processes, Bangladesh can streamline operations, enhance efficiency, and ultimately boost global competitiveness.

Bangladesh's export-oriented economy has benefited from preferential trade agreements such as the Generalized System of Preferences (GSP) offered by the EU under its "Everything But Arms" (EBA) scheme. However, as the country is set for graduation by 2026, maintaining trade competitiveness through diversification and value addition is crucial. Emerging sectors such as ICT, light engineering, and agro-processing are expected to play a growing role in the country's export.

On the import side, Bangladesh primarily imports industrial machinery, raw cotton, petroleum products, food items, and capital goods to support its manufacturing and development sectors. China, India, and ASEAN countries are Bangladesh's major import partners, supplying essential raw materials and machinery critical to its export-driven economy.

Despite its success, Bangladesh's international trade faces several challenges including port congestion, customs inefficiencies, and inadequate transportation infrastructure. The country's reliance on a single sector, RMG, exposes its economy to global market volatility. Environmental compliance has become increasingly important as global buyers demand sustainable and eco-friendly production practices, particularly in the textile, leather, and agro-processing sectors.

The upcoming LDC graduation presents both challenges and opportunities. While the loss of preferential market access could increase tariffs for Bangladeshi exports, the transition also encourages policy reforms, technological upgrades, and trade diversification. Bangladesh's focus on achieving deeper integration with trade blocs such as ASEAN, African Union and Mercosur, leveraging the Belt and Road Initiative (BRI), and expanding its digital economy can help sustain its trade momentum.



Modern technologies like Artificial Intelligence (AI) provide transformative opportunities to address these challenges, enhance competitiveness, and align with global norms such as the WTO Trade Facilitation Agreement (TFA). Bangladesh's customs processes often suffer from delays due to manual documentation and inspections. AI can address these issues by automating the processes, as demonstrated by Singapore's TradeNet system. TradeNet leverages AI to streamline electronic document submissions, classify goods, and flag high-risk shipments, enabling 90% of imports to clear customs within 10 minutes. In Bangladesh, implementing a similar AI-enabled system at Chattogram Port could transform trade efficiency. For example, AI could integrate with the existing The Automated System for Customs Data (ASYCUDA) world system, analyzing trade patterns to identify discrepancies in import-export declarations. This would reduce manual errors and expedite clearance times, significantly benefiting exporters and importers.

Bangladesh's RMG sector, which contributes over 82% of the country's export earnings, faces challenges such as delayed shipments and high logistics costs. Al can optimize supply chain efficiency, as seen in India's adoption of digital freight platforms like Rivigo that uses Al to optimize truck routes, reduce idle time, and improve delivery predictability, reducing logistics costs by up to 20%.

In Bangladesh, Al-powered logistics platforms can address bottlenecks such as port congestion and inefficient transportation networks. For instance, integrating Al into the Bangladesh Inland Water Transport Authority's (BIWTA) operations could optimize river transport, a crucial yet underutilized trade channel. Al could recommend the best routes based on real-time traffic and weather data, ensuring timely delivery of goods and reducing costs for exporters.

With increasing pressure from global buyers to adopt sustainable practices, Bangladesh must align its industries with environmental standards. Vietnam provides a relevant example, where Al tools are being used to monitor energy consumption and carbon emissions in manufacturing. For instance, the Vietnam Textile and Apparel Association partnered with Al developers to create tools optimizing resource usage and reducing water waste in garment production. Vietnam's focus on circular economy principles has led to innovations in waste recycling and byproduct utilization. Another notable example from Vietnam is how textile factories have implemented Al-based sorting systems to identify reusable materials, turning what was once waste into valuable inputs for other industries. For example, fabric scraps are now processed into insulation materials or padding for furniture, creating additional revenue streams while reducing landfill waste.

Bangladesh's RMG sector can replicate this success. Factories participating in the Partnership for Cleaner Textile (PaCT) initiative could adopt AI solutions to monitor dyeing and finishing processes, reducing water and chemical usage. Additionally, AI-powered predictive maintenance tools can help identify inefficiencies in production lines, further minimizing environmental impact and ensuring compliance with sustainability standards set by trading partners like the EU.

Similarly, the leather industry, a major export sector, can leverage AI to mitigate its environmental impact, especially in the tannery sector. This can be achieved by implementing effluent monitoring systems that detect harmful chemicals and recommend pollution-reducing adjustments. By leveraging predictive maintenance tools, industries can optimize energy-intensive machinery, significantly lowering operational costs and carbon footprints. Additionally, AI can revolutionize the design of sustainable leather products, such as vegetable-tanned leather, catering to the growing demand for eco-friendly fashion.



Despite its landlocked geography and limited resources, Rwanda has demonstrated the transformative power of AI in trade facilitation. By implementing an AI-powered Electronic Single Window, the country has slashed customs clearance times from 11 days to less than 48 hours, aligning with WTO TFA. Bangladesh can learn from this success story by deploying AI-powered chatbots to provide real-time information to traders and strengthen risk management frameworks.

Small and Medium Enterprises (SMEs) are vital to Bangladesh's economy, yet they often struggle to access international markets due to limited resources and complex procedures. Bangladesh's SMEs can benefit similarly through Al-integrated e-commerce platforms that can personalize product recommendations and improve supply chain logistics for small sellers. Al could also enable SMEs to access trade finance by analyzing alternative credit data, ensuring underserved entrepreneurs secure funding to expand their businesses.

Artificial intelligence has already marked its footprint by transforming industries across Bangladesh. For example, Unilever, by using Fordo, a precision marketing AI product, has achieved new heights in their marketing campaigns. Similarly, BAT has elevated its brand campaign execution accuracy by leveraging Shobdo, a speech recognition AI product. In the fintech sector, IDLC Finance has revolutionized its operations by utilizing Dharapat, a FinTech AI product, to process CIB reports in a record-breaking time of under 30 minutes. Moreover, bKash has experienced remarkable growth and productivity gains by implementing Nimonton and Biponon, two retail AI products.

These are just a few examples of how AI is reshaping the business landscape in Bangladesh. As AI continues to advance, we can expect to witness even more innovative applications that will drive growth and development across various sectors.

While AI holds immense promise for Bangladesh's trade sector, challenges such as limited infrastructure and skill gaps persist. Policymakers must develop a clear and comprehensive strategy for AI and disruptive technology adoption, including capacity building initiatives, public-private partnerships, and implementation frameworks. A particular emphasis should be placed on AI literacy programs for customs officials, logistics professionals, and SMEs. Collaborations with international organizations such as the World Bank or UNCTAD could provide essential technical assistance and funding for AI-driven trade facilitation projects.

Artificial Intelligence is not merely a technological upgrade but a transformative force capable of addressing key challenges in Bangladesh's international trade. From streamlining customs procedures to optimizing supply chains and promoting sustainability, AI offers solutions that are critical for the country's economic growth and global competitiveness. With government and private stakeholders working collaboratively, the integration of AI into trade processes will not only simplify operations but also solidify Bangladesh's position as a major trade hub in the Asia-Pacific region and beyond.
